*Tap fee covers the utility's costs for materials and labor to install a standard residential 5/8" x 3/4" meter*

1" Sewer Tap Fee \$870.00  
*Tap fee covers the utility's costs for materials and labor to install a standard residential 1" meter*

Regulatory Assessment 1.0%  
*PUC rules require the utility to collect a fee on one percent of the retail monthly bill and to remit the fee to the TCEQ*

A PASS THRU FEE is a third-party fee that we fill for, collect funds, and then send to the proper entity
